Membership wise it was a good year. Somehow MMS manages to change the total membership numbers each year by one or two numbers but can't seem to tell me how that happens. Per MMS we began with 2,867 Members in 35 Commanderies which includes two, Lawrence V. Kaminsky and Tipton, Under Dispensation Commanderies. December 31, 2019, we had 2,782 members and 34 Commanderies, as South Bend merged with LaPorte No. 12. Our loss of 85 members, is one of the best in a number of years. It felt like there was a lot of work going on all around the state and it was. with 130 new Knights this year.

The Recorders of the Commanderies are calling me less for help with MMS and I believe it is because as Chapter and Council are now on-line and the Secretary / Recorders need to access MMS more often and thus their minds say fresh on how to make updates to their membership. At least that is my story and I am sticking to it.

This year the Grand Commander has issued three dispensation for Commanderies to operate as a Commandery Under Dispensation.

Lawrence V. Kaminsky, UD is to be a research and holding Commandery and is not expected to confer the Orders nor receive a Charter.

Levant Preceptory, UD is to use as its official uniform, ceremonial robes conforming to and consistent with the historical traditions and practices of Templary. It is to assist Commanderies when requested to Confer the Order of the Temple in ceremonial robes.

Tipton Commandery, UD is to operate as a Commandery until such time as they shall prove themselves a viable Commandery and receive a Charter. This Dispensation expired April 24, 2020 and has not been renewed.

# **Holy Land Pilgrimage**

To the Right Eminent Grand Commander Michael F. Robbins and the Sir Knights of the Grand Commandery of Indiana.

The Holy Land Pilgrimage Committee received 2 applications this year's Pilgrimage to the Holy Land with a Minister from Raper Commandery #1 and Elkhart Commandery #31 being selected to go. Raper #1 also has sent in Funds for a Minister to be named later.

We continue to ask that each Commandery donate \$100 to the Holy Land Fund each year to help offset the costs of the Pilgrimage. If we are unable to continue to raise money either by donations, golf outing, sponsorships for these Pilgrimages we will have limit the number of Ministers who go each year to a lower number. We already have a few applications for next year's Pilgrimage that will be considered.

The 2019 Holy Land Pilgrimage Golf outing was held on May 11<sup>th</sup> at Arrowhead Golf Course in Greenfield and profited over \$3000. We only had 2 1/2 teams of golfers and over 20-hole sponsors. Thank you to all of the golfers who came out and braved the weather and supported the Golf Outing and we hope that the 2020 Outing gains momentum. A date has been determined but there is a request at the writing of this report to change the date.

Lady Monica Peterson has been diligently working on a way for us to sign up for donations through Amazon Smile, Kroger Plus and Facebook, BUT.....we need to be a 501c3. According to her there isn't one and by we, she means the Grand Commandery or the Holy Land Pilgrimage Fund. We have been told that there is a possibility to utilize the Grand Encampment Holy Land Pilgrimage information, but we will be contacting them to find out the particulars. We still think that this is a something viable for fundraising and we would really like to pursue this in the future.

We have also discussed a Holy Land Pilgrimage Jewel again and that will be discussed during the 2020-2021 year and there will be a program for this. This jewel will be worn in the same area as the other Meritorious Jewels. This Jewel would be received based on donations made to the Holy Land Fund and will have different donation levels.

# Proposal No. 6 GRAND COMMANDERY KNIGHTS TEMPLAR OF INDIANA PROPOSAL ON ADDITION TO PERMANENT FUND

Whereas through careful management, hard work, generosity of certain individuals and a certain amount of luck, the 2018 Grand Encampment Triennial conducted by the 67th Triennial Corporation generated a surplus.

And whereas the Triennial being completed, it is the general plan of the Corporation to liquidate its assets in the near future and its desire is to promote the welfare of the Grand Commandery of Indiana.

And whereas the Grand Commandery Knights Templar of Indiana maintains a permanent fund. It is the general plan of the fund that the principle and a certain portion of accumulated earnings be maintained as perpetually undependable. Only earnings in excess of that portion being spendable.

I therefore propose the following amendment to section 612 of our laws. The change being the addition shown as underlined below.

**SECTION 612:** The Purpose of the Permanent Investment Fund of this Grand Commandery is to partially finance the operations of this Grand Commandery.

The permanent and un-expendable portion of the fund shall be \$279,096.00 as of December 31, 2005 plus all per capita fees and contributions contributed to the fund after that date.

Each year, beginning with the 2007-2008 Grand Commandery year, the permanent fund shall transfer as necessary to the general fund, for operations, up to five percent (5%) of the fund effective December 31st of each year. Except that such transfer shall be limited to total return on investment earned (net income) and shall not include any of the un-expendable portions of the fund as described above, the previous calendar year end value of the permanent fund except that such transfer shall be limited as follows. The maximum annual transfer shall be no more than the amount that would reduce the permanent fund as of the previous calendar year end to the permanent, un-expendable balance of the fund. (May 2016)

Further, effective with the year ended December 31, 2020 the permanent and un-expendable portion of the fund shall be increased 2% per year to compensate for inflation. This commitment is made in exchange for a significant permanent and un-expendable contribution from the 67th Triennial Corporation to the fund.

# Proposal No. 7

# GRAND COMMANDERY KNIGHTS TEMPLAR OF INDIANA RESOLUTION ON MEMBERSHIP FUND

Whereas a special fund was created in 1980 from funds raised to support the 1979 Triennial Conclave in Indianapolis with Indiana Sir Knight Willard Meredith Avery presiding. And

Whereas that permanent fund is in the amount of \$10,000 which if separately invested has limited investment options due to its small size and could be invested more profitably in conjunction with the permanent fund. And

Whereas the purpose of the fund is to support membership development although the direct or indirect average annual expenditures for membership development routinely exceed the earnings on this special fund.

Therefore, to promote more effective management of the Grand Commandery I move that section 660 of the laws of the Grand Commandery of Indiana which currently reads:

#### MEMBERSHIP DEVELOPMENT FUND

**SECTION 660:** Whereas voluntary contributions to the W.M.A. Club (Willard M. Avery Club) were received from individuals to help finance the 54th Triennial Conclave of the Grand Encampment of Knights Templar of the United States of America convened at Indianapolis, Indiana, August 11-16, 1979:

Whereas the voluntary contributions were not needed to meet the expenses of the conclave as sufficient revenue was received from other sources:

Now, therefore, be it resolved that \$13,321.68 of the W.M.A Voluntary contributions, plus any accrued interest thereon, be transferred for the use of the Membership Committee, and \$10,000.00 thereof be invested in a permanent fund to be known as the "W.M.A. Membership Development Reserve Fund" and the interest income derived there from be used only for membership development. (*Adopted 1980*)

Be repealed.

And that the \$10,000 permanent portion of the Membership development fund be transferred to the Grand Commandery Permanent Fund and included as part of that permanent unexpendable fund. And that any expendable funds in the Membership fund (the amount in excess of \$10,000) be transferred to the general funds of the Grand Commandery.
